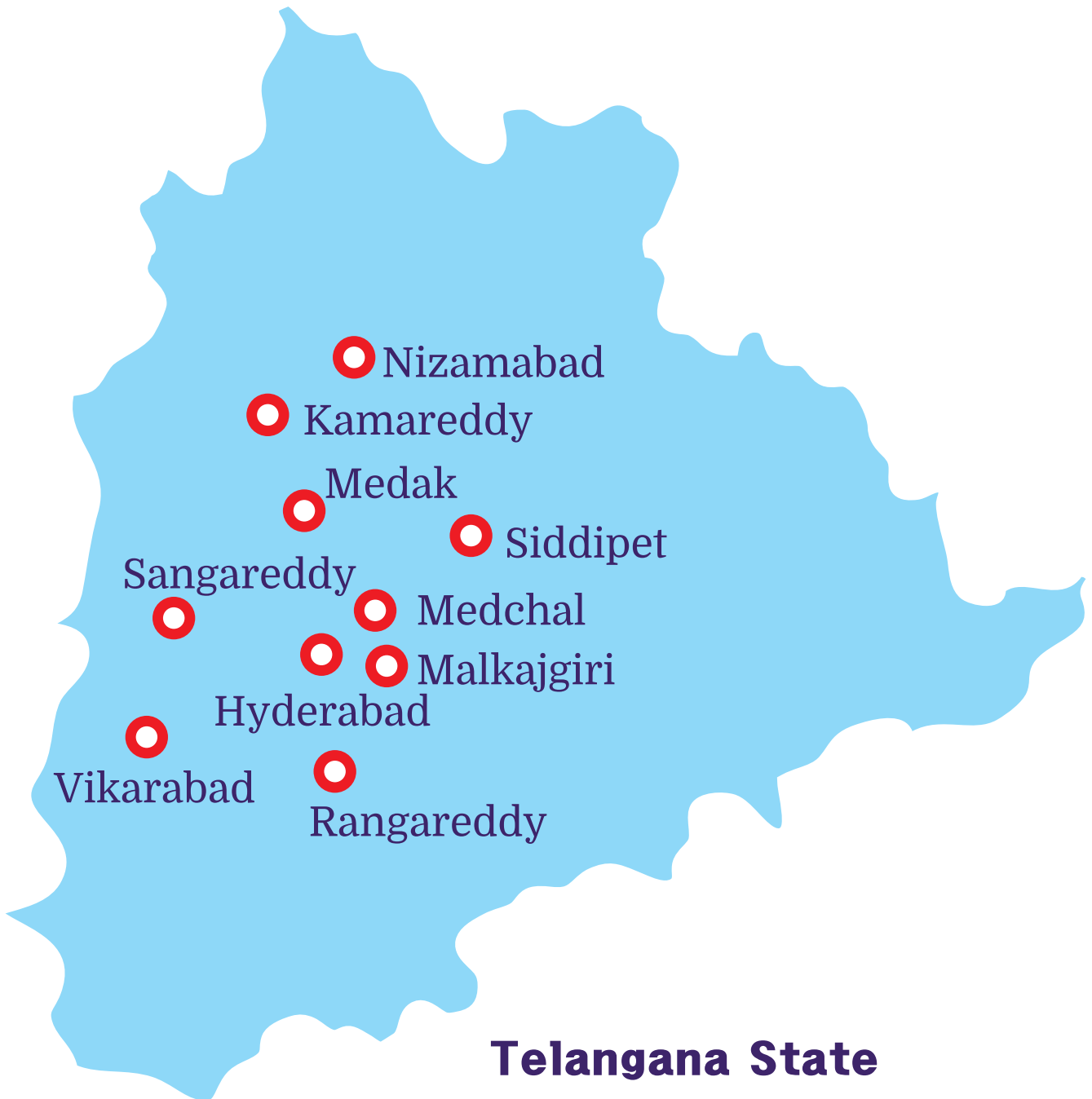

The program aims to empower women from different sections of society specially those who are from marginalized communities, socially backward, economically poor and socially side lined.

## Organizing & Empowering Women Self Help Groups (SHG's)

HASSS understands that the best way is to organize, sensitize and enable them in the thinking process and workout modalities collectively towards their development in all sectors. The prime objective of the self-help groups (SHG's) could be summarized as follows:

- \* Organize the vulnerable poor into small functional groups (SHG).
- \* Each self-help group comprise a minimum 10 and maximum of 20 members.
- \* Members meet at prefixed date and to conduct group meetings.
- \* Introduce savings as per their economic conditions and practice inter-lending amongst members.
- \* Introduce books at SHG level & identify and train the animators who can document.
- \* Identify office bearers (group leaders) in a democratic manner.
- \* Capacitate SHG members/leaders to take up group responsibility.
- \* Promote net working among the groups in the village / block to expand base.
- \* Identify and Discuss about the common issues being faced and how it could be resolved by themselves.
- \* Avail government schemes / programs / subsidies meant for their development.

### Concept of Thrift

- \* Introduce savings among members of the group(s)
- \* Provide accessibility to easy credit
- \* Extend loan to member/s wherein the group shall decide the Quantum of loan & repayment
- \* Recycle the savings, repayments to cover other members of Group

### Time Frame & Withdrawal

- \* HASSS would extend all the necessary support and accompany groups for a period of six years
- \* In the event of any misunderstanding; either party could withdraw with one month notice

### Criteria for Extending of Loan

- \* HASSS will extend loan to the group after a period of one year
- \* Regular conduct of meetings and update the books of accounts at Group level
- \* Group leaders and members actively participate in the meetings
- \* Regular savings by members and inter lending practices followed

### Repayment Schedule

- \* Terms and Conditions as stipulated by HASSS and Self Help Groups
- \* Term of repayment of all loans is fixed for a period of ten months with two months grace period

## Achievements

- \* Women have emerged as leaders in the villages, influencing family, community and the village.
- \* Women have taken responsibilities in organizing meetings, savings and credit programmes; they also maintain funds, loans given to other women.
- \* Some of our SHG leaders contested in Election for Panchayat ward members and village Surpanch's resolved by themselves.
- \* Avail government schemes/programs/subsidies meant for their development.

## Role of Field Based Animators

Field based animators are appointed by the organization to take up social mobilization, organizing meetings at the group level and explaining about the aims and objectives of Self-Help Group. Periodical conduct of meetings and nurturing of groups activities are taken up by the animator and after two / three months only the Executive Director approves the group formation.

# Case Study 1

- Name of the member - **B. Laxmi**
- Name of the Group - **Vinayaka HASSS Self Help Group**
- Name of Village - **Pragnapur**
- Type of activity - **Vegetable Vending**
- Amount extended first loan - **Rs. 12,500/-**



**Mrs. B. Laxmi** is 38 years old and active member of Vinayaka HASSS Self Help Group Pragnapur village. She is married and has Three Children while her husband B. Kumar is an Auto driver unable to earn sufficient to sustain the family, constantly under stress for the loan obtained from the bank in COVID time. They have to repay the monthly installment to the bank for the Auto loan obtained, meet their three children's educational needs as well maintain the family. In this situation B. Laxmi thought of starting a vegetable business. She has sufficient knowledge to manage vegetable business. With this business income she has to meet the household expenses such as rent for the vegetable, shop, and electricity and also support her Children education.

She had expressed her difficulties in the group and sought a loan on priority basis so as to expand her business. The group members are fully aware about her economic conditions and the group agreed to extend loan of Rs. 12000/- she contacted the local vegetable wholesale supplier who everyday in the evening would take the order and supply the next day morning fresh multiple vegetables at her door step. This resulted in saving her time, transport and enhanced her margin of profit by avoiding middlemen. As a result the business in her stores has gradually increased and now she is able to earn around Rs. 12,000/- to Rs. 15,000/- per month after meeting all the recurring expenses. From the earnings she repays the loan of Rs. 1,250/- and interest to the group and the balance is used by Mrs. B. Laxmi for household expenses. She is very thankful to HASSS and the group members for according priority and extending loan.

## Case Study 2

Name of the member	- <b>Gopu Sundari</b>

Amount extended first loan	- <b>Rs.10,000/-</b>



Mrs. Gopu Sundari is married and has two children while her husband is a Private Employee in small Company unable to earn sufficient to sustain the family and their two children's educational needs as well maintain the family. However one of her boy child was married. The Second girl Child is still pursuing her graduation.

Mrs. Gopu Sundari being a school dropout and her parents were managing a grocery store she has sufficient knowledge to manage a grocery store. With initial investment of Rs. 40,000/- wherein she sold all her jewels and established this grocery store. The monthly earnings are around Rs. 8,000/- wherein she could contribute to the family. Now she has been requesting the group members to accord priority to her loan application as she has to support her daughter education and the only means is to earn from grocery store. The group members were kind enough and approved her loan of Rs. 10,000/- wherein she purchased additional stocks of groceries. With the availability of more varieties of groceries more customers started to patronize and the wholesale dealers have extended one month credit with free delivery to store. As a result the business in her store has gradually increased and now she is able to earn around Rs. 9,000/- a month after meeting all the recurring expenses. She is very thankful to the group members and HASSS staff for according priority and extending loan. Her daughter now intends to pursue her post graduation in this academic year.

# HASSS - Kolping India Program Activities FY 2021 - 2022



The Hyderabad Archdiocese Social Service Society in partnership with Kolping India started with 300 members in the year 2018; while in 2019 the coverage was enhanced by 400 members. Thus we cover 700 members in eight villages and are successfully continuing with the program activities.

Kolping Program Coordinator visited the target villages took up nurturing of group activities and explained to members about the aims and objectives of Kolping India with a sole aim to reduce poverty through the self-help concept. Members have to pay their annual subscription once a year and have been assigned registration number for all future correspondence.

HASSS provides the required books to be maintained at the group level and the Kolping Program Coordinator during her visit to the target villages participates in group meetings, helps in writing the minutes as well and ensures the group books are up to date. Kolping Regional Program Coordinator along with a select office bearers of the group visit and explain about the group dynamics, need for regular savings, inter-lending practices and role of the group office bearers. It is to be noted that 80% of the members from all groups have availed internal loans at least once. After completion of one year the common issues faced by the group are introduced and help them to find solutions to the issues introduced in the group by the group members themselves. Groups are further educated on the concept of "Help for Self Help" As on date 59 Kolping India Family Groups have been promoted. Select group leaders along with the regional program coordinator have compiled stakeholders & Village profile to further initiate and introduce programs.

During calendar year an amount of Rs. 93,150/- was earmarked towards education measures i.e. capacitating the members on various subjects. 18 capacity building programs were organized for the stakeholders comprising of 535 members at the grass root during the year.

## During the year 2021 - 2022 Kolping India has provided loans amounting to Rs. 5, 35,000/- the breakdown is as follows

- \* Rs.100,000/- revolving fund to 10 Kolping members for IIGP.
- \* Rs.150,000/- revolving fund to 3 Kolping members for housing (Rs. 30,000/- is subsidy).
- \* Rs. 55,000/- revolving fund to 5 Kolping members for milch animal.
- \* Rs. 75,000/- revolving fund to 5 Kolping members for Sanitation program (Rs. 25,000/- is subsidy)
- \* Rs.30,000/- revolving fund to 3 Kolping members for Vocational training program.
- \* Rs. 125,000/- subsidy fund to 1 Kolping Group for Collective Income Generation Program(CIGP)

**Syed Nafisa Begum** belongs to Suguna Kolping Group and her membership ID: TS/03/35/003 enrolled in the year 2019. This family comprises of husband, wife one son studying in 4th standard and aged widow mother. Her husband works as agricultural labour and she support by taking up tailoring works assigned by local tailors from Gajwel town. The monthly income is around Rs.18,000/-

This family owns a small pocket of land wherein their existing old house was demolished and they have started constructing a house couple of years back consisting of two rooms with RCC roofing and toilet cum bathroom outside. However the house was not completed. Due COVID 19 Pandemic had put this family in difficulties as they could not earn anything they were left with no other option than to occupy the incomplete house as they could not afford rent.

HASSS – Kolping India had provided relief for this member in the year 2020. Taking note of the member living conditions the group had recommended that Housing Support Program (HSP) be extended. The application after due process had released the amount in October 2021. With the loan amount and the little saving this initially completed the Interior of the existing house in all aspects and occupied it; while the external plastering of the building with cement will be taken up as and when they have adequate money.

This member is very grateful and thankful to HASSS-Kolping India for the support extended during the difficult times of COVID 19 PANDEMIC as they have a solid concrete roof and stay safely.

**Khaza Bee** family comprises of her husband, two children and aged parent. Eldest daughter is in 10th standard and son in Intermediate.

This family owns 1 ½ acres of agricultural land wherein paddy, cotton and seasonal vegetables are cultivated. The produce from the land is exclusively used for the family and vegetables after consumption; excess is sold in the market. This family spends much of time in their farm land wherein they have put up temporary shed and only during the nights they come home to rest. As per family the agricultural source/ returns in minimal and hence they have shifted their occupation to milk vending. They have two yielding buffaloes and the member had been requesting loan to purchase a 3 milch animal. Group members taking note of her regular attendance, savings and active participation had extended a loan of Rs.15,000/-

With this loan amount, savings the member had mobilized the deficit to purchase a milk yielding buffalo costing around Rs. 35,000/- With this addition the members purchased 3 milk yielding buffaloes. The total milk yield is around 15 to 17 litres of which one litre of milk is consumed for the family and 15 litres is sold @ Rs. 60/- per litre. Green fodder is available in their agricultural land which reduces their overall expenditure.

Khaza Bee and her family is extremely happy for the loan extended as this is the main source of income to sustain the family wherein everyone works and contributes.

## Details of Execution

As soon as the funds were made available for this program the Executive Director Fr. K. Jaya Prathap had a meeting with the project coordinator Mr. Simon to chalk out the plans for procuring the dry ration, mobilizing volunteers required for the identification and distribution of food kits to the vulnerable poor and displaced persons in various parishes of Hyderabad Archdiocese.

Volunteers after enumeration of the poor displaced families as well transgender submitted to the organization which collated the data. Quotations were invited from various food grain merchants for supply and quantity informed. Based on the best price offered, quality and credibility firm order was placed and cheque issued for the supply of food grains in phases that which was informed by HASSS. The volunteers were called in for a brief orientation at the Hyderabad Archdiocese Social Service Society (HASSS) and were also asked to pack each food kit neatly as per the quantity and items prescribed. Following is the list of food grains / grocery packed in the kit:

The identified persons were called to the church premises and explained about Hyderabad Archdiocese Social Service Society its activities and the generous contribution made by St. Agnes Church, New York – United States of America. 385 economically poor displaced families including Trans Gender were provided with food kits. The beneficiaries are grateful for timely help at this difficult time.

✳ **Assistance to chronically ill / patients:**

The economically poor, aged, individuals suffering various chronic ailments were provided cash assistance @ 500/- per individual based on doctor's prescription and submission of medical bills. 80 persons were supported under this program.

✳ **COVID 19 Vaccination Drive:**

COVID 19 inoculation drive was promoted by educating the housemaids, essential workers and other poor daily wage earners who could not visit government centers. HASSS through its contact with the medical staffs from St. Theresa's Hospital, Gandhi Hospital assisted in this inoculation drive by deputing their staffs. A total of 205 members eligible were administered with COVISHEILD vaccine.

✳ **Accounting:**

HASSS the implementing organization has maintained a cash book wherein all expenses incurred for this program are recorded with supporting bills / vouchers. It is to be noted all payments more than Rs. 10000/- are made through crossed cheques as required to promote transparency.

✳ **Visibility:**

At the time of distribution HASSS had displayed a banner depicting the generous contribution made by St. Agnes Church, New York, United States of America as well the other donors Ms. Mary O'Connor and Fr. Richard Adam towards this program. The local media i.e. TV and newspaper covered the food distribution undertaken in select areas which enhanced the Catholic Church's commitment and credibility.

✳ **Conclusion:**

The economically poor, aged, individuals suffering various chronic ailments were provided cash assistance @ 500/- per individual based on doctor's prescription and submission of medical bills. 80 persons were supported under this program.

✳ **Assistance to chronically ill / patients:**

This is a simple program aimed to provide dry ration food kits to the vulnerable poor, migrants, transgender who have been displaced due to COVID 19. It heart rendering to hear the difficult circumstances and their living conditions; the support extended is ray of hope. Chronically ill patients who were supported are grateful. The COVID 19 vaccine drive for the daily wage workers, housemaids, religious and other labor community is very much appreciated and acknowledged.

## Sneha Hastham

Cancer is emerging a major public health concern in many countries including India. The World Health Organization reports that, behind heart disease, cancer is the second largest cause of mortality worldwide. Incredibly, nearly half of cancer-related fatalities worldwide can be attributed to avoidable risk factors, according to a recent study. On the bonus side, research demonstrates that a number of cancer risks and deaths can be averted by managing and limiting modifiable risk factors.

HASSS Sneha Hastham Cancer Prevention and care campaign is creating, promoting Awareness on cancer. It is our humanitarian concern of each individual, each citizen to support the patients fighting with cancer in the real sense they are the true warriors fighting the war within themselves. Our approach should be to promote preventive approaches to health disasters. The campaign started in Hyderabad with the support of Caritas India in the year 2019 and with great difficulty due to Covid-19 the campaign has spread across the archdiocese of Hyderabad from School to Colleges, Communities to corporate which is getting transformed into a movement to create awareness on cancer and gather support from different means to support the cancer patients. HASSS Sneha Hastham has conducted different engagement activities and program to reach out the public in creating awareness and to visit cancer patients as per the survey done by the volunteers and staff.

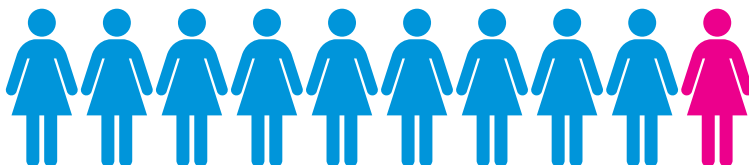
Studying the data, however, also reveals that these deaths would have been avoided if those people had been able to control their controllable risk factors, particularly the major ones controlled by lifestyle choices and poverty levels.

### Rise of Cancer in India

India ranks third among nations in terms of highest number of cancers. Over 13 lakh people in India suffer from cancers every year, as per the National Cancer Registry Programme report. Sedentary lifestyles, increase in urban pollution, in addition to rise in obesity, tobacco and alcohol consumption, are said to be the reasons behind the rise. The Indian Council of Medical Research (ICMR) estimates that there will be a 12 percent rise in cancer cases in India by the next five years. The most common forms of cancer affecting the people of India are breast cancer, cervical cancer and oral cancer.

### BREAST CANCER

One in every 10 new cancer diagnoses in India annually, is of breast cancer, as per reports and it causes the most number of cancer-related deaths in women.



## CERVICAL CANCER

This type of cancer develops in the cervix of women. The abnormally dividing cells can eventually spread to other parts of the body. Almost all cervical cancers begin with a Human Papilloma Virus (HPV) infection that spread through sexual contact and from mother to child during pregnancy. Early vaccination and screening can prevent the disease while with early diagnosis; cervical cancers can be successfully treated.

## ORAL CANCER

Oral cancers occur on the lips, floor of the mouth, cheeks, tongue, sinuses and the pharynx and look like white ulcerated patches that eventually grow into a bigger red patch on the surface. Tobacco, betel leaf and alcohol consumption as well as HPV infections are said to increase the risk of oral cancers.

### Role of Sneha Hastham

In recent decades, an increasing number of people under the age of 50 are developing cancer. Based on the cancer registry data it is estimated that there will be about 800000 new Cancer cases in India every year. HASSS Sneha Hastham makes every effort to reach out to the people in urban and rural areas with different awareness programs. The campaign has conducted a range of multi level activities and programs like medical camp, counseling program, volunteerism, Awareness programs, fund raising programs and cancer support programs to the cancer patients.

It is the social responsibility of each individual to educate and create awareness at their personal and social level so that the deadliest disease called cancer can be eradicated. HASSS Sneha Hastham takes up this social responsibility to strengthen the program with its different stake holders, NGO's, Volunteers and like minded social worker's who together can make a difference and make this world a Healthy one.

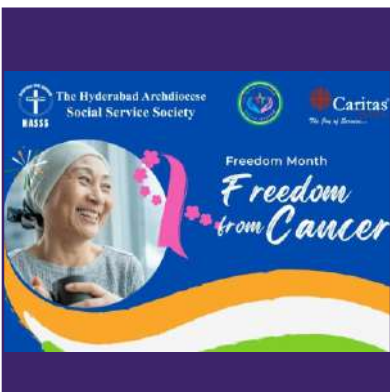

# Child Parliament

## Background

Children are considered as the future wealth of any nation. When children are happy the villages are happy. Hyderabad Archdiocese Social Service Society in collaboration with AP TS State Social Service Forum has chosen the least backward area of 12 gram panchayats of Tadwai mandal in Kamareddy district to implement CFLG pilot project. The CFLG aims to help integrate child participation and child friendly approach in the local governance process. National CFLG Strategy was formulated in 2011.

## Operational Area

This project has been executed in 12 Gram Panchayat in Tadwai Mandal of Kamareddy District.

## Objective

The Child Friendly Local Governance (CFLG), is to provide overall guidance to the government in realizing and mainstreaming the rights of children (Survival, Development, Protection and Participation) into the local government system, structure, policies and process.

As a result of its positive experiences with various past interventions such as Child Friendly Villages (CF VDC), Area Development Approach, Local Governance and Community Development Program, Promoting Municipal against Child Labor, the Ministry of Local Development (Later Ministry of Federal Affairs and Local Development) started to formalize its initiatives for CFLG in 2007. CFLG committees has been well practiced with an example in South Asia. CFLG also contributed for integrated and coordinated interventions on child rights considering the four major rights of children.

- \* Non-Discrimination
- \* Best Interests of the child/children
- \* The right to survival and development
- \* The views of the child

## Achievements

- \* Sensitization program on child rights, gender equity in 12 government schools covering 12 panchayats comprising 529 children wherein the school teachers as well the principals participated.
- \* Sensitized the Somaram Balasabha to keep the school environment and village clean
- \* How to enhance the participation of children in local institutions
- \* Officials from various Panchayat Raj Institutions were also sensitized on the importance of Child Rights and Protection.
- \* At the Mandal level Child Protection Committee has been constituted.
- \* 12 Bala Shabas at the Gram Panchayat Level and identified issues. Passed resolution and submitted to Gram Panchayat.
- \* Inclusion of child representative at the Gram Panchayat Level

- \* Need to have an Inclusive Gram Shaba with representatives from self-help group (SHG's), youth and farmers associations/groups
- \* Somaram Bala shaba has taken the responsibility of cleaning the school premises as the students would like to participate, own as responsible citizen.

## **New Findings**

- \* The study recommends interventions on national policy and political advocacy, support capacity building programs, update existing CFLG reference materials, develop local champions and resource persons and host norm changing events and campaigns. The study also recommends providing technical facilitation and support services and Child Friendly Local Governance Program (CFLG).
- \* The organization primarily focuses on promoting Sustainable Development Goals (SDG's) as mandated by the United Nations. One such program is that to promote Bala Sabhas i.e. Child Friendly local Governance as per the directives of the Supreme Court as enshrined in the United Nations Convention on Rights of Child.



## **Case Study**

Mr. Sanjeevulu murdered his 6 months pregnant wife and he too committed suicide by consuming poison. This couple has a 3 years old girl Sahasrika who is being taken care of by the old grandparents who are very poor. This orphan girl was identified by the Bala Sabha and mobilized Rs. 5000 towards cause and recommended to village Grama Sabha mobilized one lakh Rupees to the future needs of this girl child. With the intervention of Bala Sabha and Gram Sabha the case was referred to the District Child Welfare Committee at Kamareddy and it has come forward to sponsor Rs. 4000 and it was approved to the immediate guardian by the government for the next 3 years.

## **Conclusion**

This program has been executed successfully with the cooperation of APTS Forum, UNICEF in 12 remote Gram Panchayat of Tadwai Mandal. Taking note of the success the agency has extended the program.

## Economic Empowerment through Poultry

Sanugundla Samson Reddy is a poor farmer. His wife Arogyamma is of great support and encouragement for him to take up this project. Both are very much interested in poultry and the couple has 2 married sons living separately living at Medinipur village of Kondapaka Mandal, Siddipet District. Samson Reddy without depending on anyone does work all by himself with a small piece of land. The economically poor couple was provided with 25 birds wherein he was explained in detailed as how to multiply and over a period time should be a secondary source of regular income. Being a part of the exposure program he had raised a lot of questions, queries which enabled him gain further knowledge on poultry as a source of regular income.

### Project Initiation

By following the guidelines provided, guidance by the program coordinator the family on a regular basis takes care of the small PFPP in their backyard. With organic feeding, timely medical care the birds are healthy. In a few months' time the layer birds will start laying eggs and all birds will weigh in more than a kilogram each. The eggs are in great demand and couple consumes twice a week resulting in enhanced nutritious intake. 3

### Present Status

With the increased knowledge on PFPP Samson Reddy is able to implement this Income generation activity, the secondary income he is able to full fill the basic needs and clearing his old debts. He is grateful to Caritas India for all the support and cooperation given through HASSS.

### Story of Ravi Kumar's family Economic Empowerment through Birds rearing

Ravi Kumar - 32 years living with his family in Markook mandal, Siddipet District. Ravi being financially poor but rich in the works that he does a hardworking man who strives hard for his family to give them a decent living. He has one girl child four years old. Mr Ravi is a daily wage labour and to sustain his family he is engaged in different works. His wife Sunitha is a domestic worker and takes care of the house.

#### Project Intervention

As part of HASSS project training programs Ravi had to take days off to attend the training on Livestock and Veterinary care. He was interested and couple of occasions had expressed to the coordinator his passion to own and maintain poultry.

The coordinator has availed the services of Mallesh as resource person to explain to the stakeholders about breeding, feeding, common diseases which affects the bird the most, precautions to be taken. He is one of the selected member for this program and was instructed to construct a small poultry shed and at later date was provided with 25 "Giriraj" chicks which is taken care by himself and his wife. The birds are healthy and in a couple of months will start laying and few will be ready for culling. Ravi states that the training program had been vital to strengthen his desire and start poultry farm as primary occupation.

#### Present Status

All the 25 birds are healthy and being safeguarded. Mr. Ravi plans to hatch the first eggs he gathers and only later he has plans to market. He further states that poultry is good viable alternative source of income and livelihood. He thanks Caritas India and HASSS for the sharing their views on PFPF.

## Nutrition Garden

A meeting was organized for all the farmers in the target villages and self-help groups regarding the nutri organic farming and following are the objectives of Nutri Garden

- ✧ Importance of nutri kitchen garden
- ✧ Cultivate vegetables in backyard with waste water
- ✧ Enhancing the intake of vegetables by family members
- ✧ Reducing household expenditure

Fruits and vegetables grown in home gardens play an important role in filling the gap in nutritional needs by providing access to food that is harvested, prepared and consumed by family members. Nutrition gardens enhance dietary diversity by providing micronutrients through constant supply of fruits and vegetables sufficient to meet the family's requirements. Thus, nutrition gardens can prove to be a sustainable model for providing food security and diversity to combat malnutrition at the household or community level. Fruits and vegetables from the kitchen gardens are good source of micronutrients especially in the poor households. If the daily food is improved the health in the family also improves. Rural areas have ample space and establishing a kitchen garden is far simpler as non-farm families too are involved in activity.

With this background we trained 50 farmers from the target villages who showed interest in natural farming. They were shown how to prepare manure and ways of cultivating it. Different leafy and common vegetable seeds were provided to members who expressed interest. The village common place was selected for the practical training demo starting from digging, preparation of manure and planting of the seeds. Also we explained in detail while practical work was going about the preparation of the fields, sowing, use of manures and pest control methods to get more yield from it.

### **Madanu Kaspal family growing organic vegetables**

Mr. Madanu Kaspal from Teegul village, Jagdevpur Mandal and he lost his wife 10 years ago. He has a grandson who is studying in 7th standard. Madanu Kaspal was all alone after his wife left him for heavenly abode, the family do not own any land and all that they have is their house with front courtyard as well in the backyard. He was motivated to make use of the land and thus go in for cultivating organic vegetables.

### **Project Intervention**

The Ujjwala project phase II that has taken up by HASSS has turn out to be a support for the people in need who was looking for some kind of support with Ujjwala phase II we have educated the targeted people on improving their livelihoods with cultivating vegetables, multi cropping and different awareness and training program. Mr Madanu Kaspal attended the training and was inspired with the session on organic farming and promotion of vegetables. The coordinators and animators motivated and explained the need of organic farming and health benefits of it and simultaneously it will generate income for the family. To boost them and encourage them we have provided them with seeds which they can grow in their backyard kitchen with organic method. The training has indeed helped them and which given them proper knowledge and understanding of organic farming and better yield

### **Present Status**

With the training that Mr Madanu Kaspal has received, he is able to implement this activity for a better income generation. He able to take care of the basic needs, he is also explaining his grandson about the importance of organic farming and his grandson spends time with his grandfather in the work. Madanu Kaspal is happy that he is able to give his grandchild a healthy and nutritious vegetables. He is happy for all the support rendered to him from Ujjwala team

Chinnabathini Praveen comes from poor agricultural family. He lost his mother when he was very small and being the elder son he had to take care of the family. His father did not get second marriage because of the children and also he is not well and aged. Praveen got married 2 years back and has a small kid of 5 years old. His wife is a great support in cultivation of different types of vegetables. He has half an acre of land in which he grows seasonal vegetables. They were struggling a lot to fulfill their daily basic amenities sufficiently and sometimes have borrowed money from others for high interest. Still he has to pay the debt.

### **Project Intervention**

During the farmers meetings and village awareness meetings Praveen attended and was inspired about organic farming and promotion of vegetable gardens. The Ujjwala staff have motivated him to do organic farming and promote vegetable gardens to get additional income. Then in order to encourage him toward promotion of vegetable gardens from Ujjwala project we have provided Vegetable seeds and tying in his backyard with organic farming methods, Praveen is following the organic farming methods which we were given the knowledge. Ujjwala organizer has helped to him in preparation and use of Organic pest repellents. With this he has expected to get good yield and second source income.

### **Present Status**

Praveen with the increased knowledge on Nutrition garden is able to implement this activity, through this secondary income source, he is looking forward from this organic gardening a lot of income to fulfill the basic needs and clearing old debts. He is grateful to Caritas India for helping him to cope with life and showing him the path to take care of his family through HASSS and Ujjwala-II intervention

## Root zone Fertigation Technology (RZFT)

The root zone of plants is the area of soil and oxygen surrounding the roots of a plant. Roots are the starting point of a plant's vascular system. Fertigation is the practice of applying fertilizer solutions with irrigation water, typically through a micro sprinkler or a drip system. This practice developed to cope with the arid climate and aims to conserve reclaimed water, it has the potential to reduce nutrient leaching and subsequent.

HASSS has taken up the Ujjwala project Phase II and educated on improving livelihoods, vegetable cultivation and multi cropping and RZFT through awareness meetings and training programs. During the farmers meet and village awareness meetings both V. Narsamma and her daughter in law attended and were inspired about organic farming and promotion of RZFT. The Ujjwala staffs have motivated them to do plantation with RZFT.

Through this RZFT we have planted 10 fruit trees in the Jagdevpur mandal Siddipet district.

Narasamma lost her second son due to road accident leaving wife and a baby girl 8 years old orphans with his mother. Her daughter in law is still under depression even she wanted to end her life. With lot of counseling given to her by the Animator she is able to cope up with life now. So growing some fruit trees by using root zone Fertigation method they are happy and busy with their work.

He has one acre of land and grows seasonable vegetables. His mother sells the vegetables. So Shree Hari said that if he grows the fruit trees his parents also can help him in watering and manuring when they are keeping healthy. Shree Hari also goes for coolie work in order to take care of the family and see to the education of his sister.

### HASSS Intervention

HASSS has taken up the Ujjwala project Phase II and educated on improving livelihoods, vegetable cultivation and multi cropping and RZFT through awareness meetings and training programs. During the farmers meetings and village awareness meetings Shree Hari attended and he was inspired about organic farming and promotion of RZFT. The Ujjwala staffs have motivated him to do plantation with RZFT. Then in order to encourage him toward promotion of RZFT from Ujjwala project we have provided one "Mango tree" with organic farming methods.



### Background of this Program:

This project has been planned post COVID 19 Pandemic wherein the government has announced reopening of schools in the phased manner. The economically poor daily wage earners, single women headed families who were displaced due to the pandemic have not only lost their monthly regular income but were put to a lot of hardships especially single parent / widow with two or more children were finding it difficult to pay the school fees, uniform, note books and school bag. The Hyderabad Archdiocese Social Service Society had received numerous requests from various parish priests forwarding the request from economically poor families to be supported towards their children's education. Taking note of the socio-economic conditions of such poor families, we have planned this project to assist by providing note books and a school bag to the poor children identified by the respective principals.



### Achievements of the Physical Targets

As soon as the funds were made available the Executive Director had called in for quotations from various note books, school bag suppliers. Based on the credibility, quality and price firm order was placed for the supply of note books and school bags. After discussing with a few school principals; it was decided that we provide following to each of the student:

- \* Primary & Upper Primary classes – 10 Long note books, one box with 2 pencils and one eraser
- \* High School – 15 long note books, one geometry box
- \* One 200 ml of hand sanitizer
- \* Two face masks
- \* One school bag with logo



A group of youth members assisted in neatly packing the book sets along with the school bag with markings i.e. upper primary and high school. As per the prefixed date the Executive Director along with the Kolping Coordinator and a youth volunteer informed the principals and distributed the note books, bags to the economically poor children.

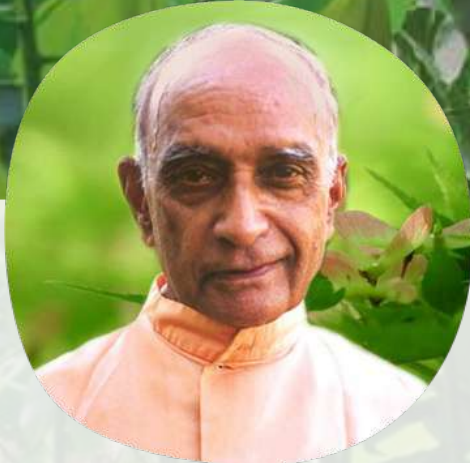

She now has regular customers who only get it stitched from her, and she is really happy with the work that she is doing. She is able to take care of the family way better than ever before.

## EUROPEAN RETURNEES REINTEGRATION PROGRAM

The Hyderabad Archdiocese Social Service Society (HASSS) facilitates and extends support to the European Returnees who have overstayed their visa period and have decided to return back home. Returnees are mostly from Telangana i.e. within the jurisdiction of Hyderabad Archdiocese.

European Re-integration Network program of the respective country assists migrant / family with safe passage to their home country and also extends grant support for their re-integration. The returnee's application is processed by the overseas partner, later referred to Caritas India with an unique identification number as well the returnee details to the service provider i.e. HASSS. HASSS after the referral contacts the returnee for a meeting in person at a prefixed date wherein the policies and procedures are explained in detail with time frame and grant to be made available.

HASSS facilitates the returnee in working a detailed business plan with feasibility along with documentation allowing sufficient time. The business plan is later submitted to the Caritas India which in turn forwards to their counterpart for their scrutiny and approval. Based on the approval the grant amount is released after following procedures. The service provider also through phone calls and visit to returnee's place evaluate the success or otherwise of the program. During the year we have the following cases as on 31.03.2022.

## Beautician Course

The Hyderabad Archdiocese Social Service Society has been working almost 50 years serving the vulnerable poor and marginalized through its multi-faceted poverty reduction programs. A brief interaction with the youth in the city parishes various reasons have been attributed and most common are

- ✧ Single earning member in the family
- ✧ Monthly Rental
- ✧ Need to take care of children left behind while parents go to work
- ✧ Education given secondary importance

The salaried class finds it extremely difficult with the income as they have to meet the recurring expenses compelling them discontinue with their education. Many NGO's have made attempts by starting bridge courses for such students to mainstream but it is no use for the economically poor students. Over the years given the family circumstances they are compelled to work as housemaids in the vicinity or take up employment in small garment making industry to support their family.

Interactions with such school dropout adolescents they have expressed various short term courses wherein their employment opportunities are high. Though youth have a desire to acquire skills, gain experience they lack confidence and the capital required to undergo the training course as well for establishing a unit.

This course was informed to all the city based parishes to motivate school dropout adolescents / youth to undergo this training which is market driven and has scope for employability. The course fee is highly subsidized @ 14000/- while subsidy will be extended to economically poor students on case to case basis.

HASSS on its part had allocated two classrooms for conducting this training had taken up fixing of mirrors, acquiring beauty products and accessories. While Christiana Chen proprietor of "Women World" chain of beauty parlors had donated three saloon chairs, one trolley & one shampoo chair.



## Commencement of the Course

On 08th March 2022 the Beautician course was officially inaugurated by HE Cardinal Anthony Poola on “Women Day” with a sole aim to empower young adolescents / youth / women in and around Secunderabad at HASSS Training cum Formation Centre. HASSS had taken the technical guidance of Christiana Chen and have worked out the syllabus along with Ms. Swapna, Anil the course instructors. The course is of two months duration with classes from 9am to 1 pm which includes theory and practical classes. The course covers the following subjects:

On successful completion of the course the trainees are provided with certificates. Interested candidates will be provided placement as interns in various beauty salons.

### Course Fee

This course is highly subsidized and 12 young adolescents / women have enrolled, successfully completed this course and have been provided with placement.

### Conclusion

This program primarily focuses on adolescents / youth who are mostly school dropouts and the sole aim to promote the skills which in turn will enhance their employability. Majority of the first batch trainees have been provided with placement. In the event of the trainees desirous to acquire more skills they can go in for professional courses promoted by various cosmetic agencies.

A new partnership and a new horizon drives HASSS towards a complete new approach into the world of CSR initiative.

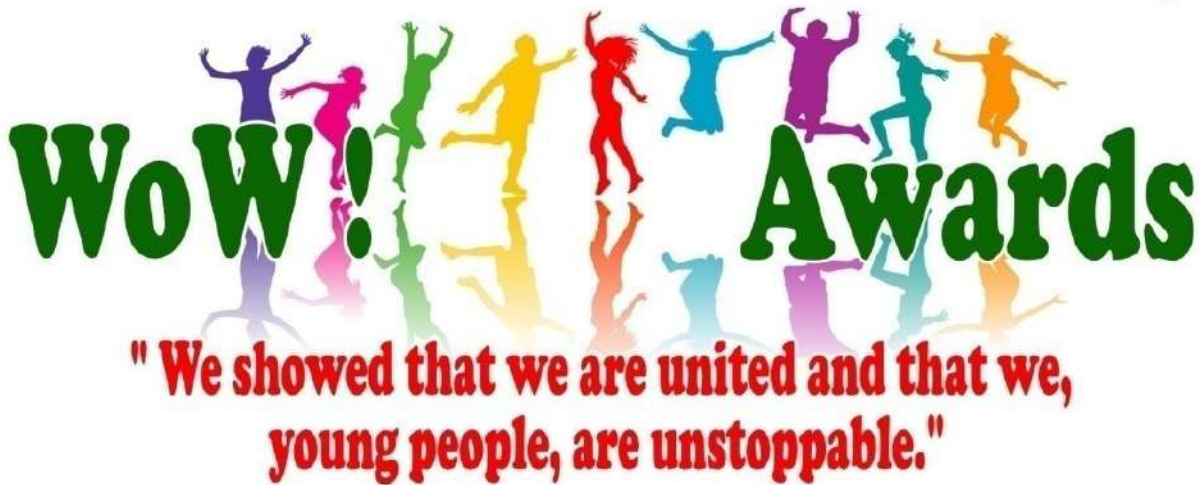

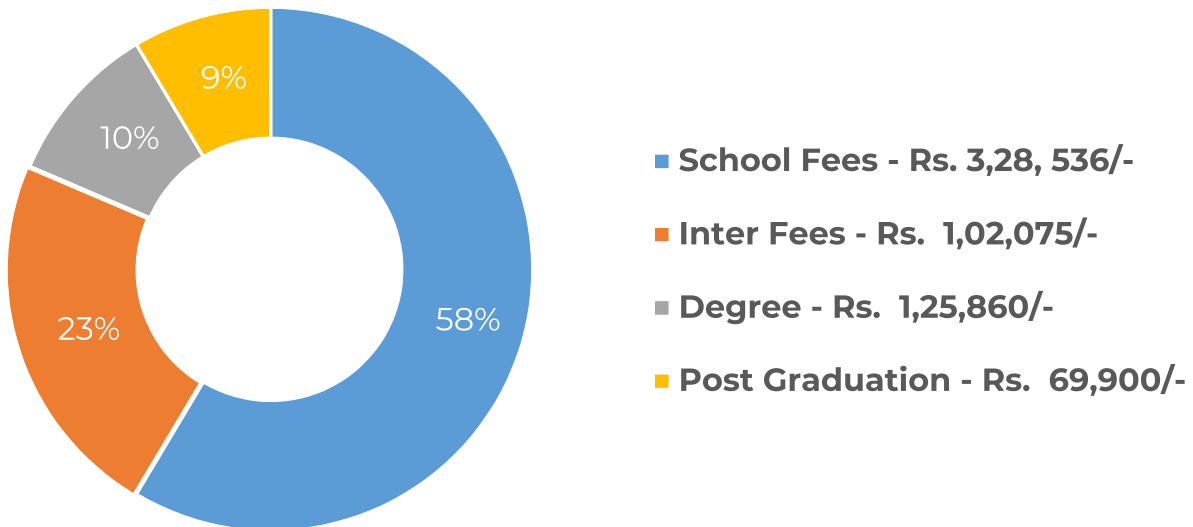
### Charity for the Year 2021-2022

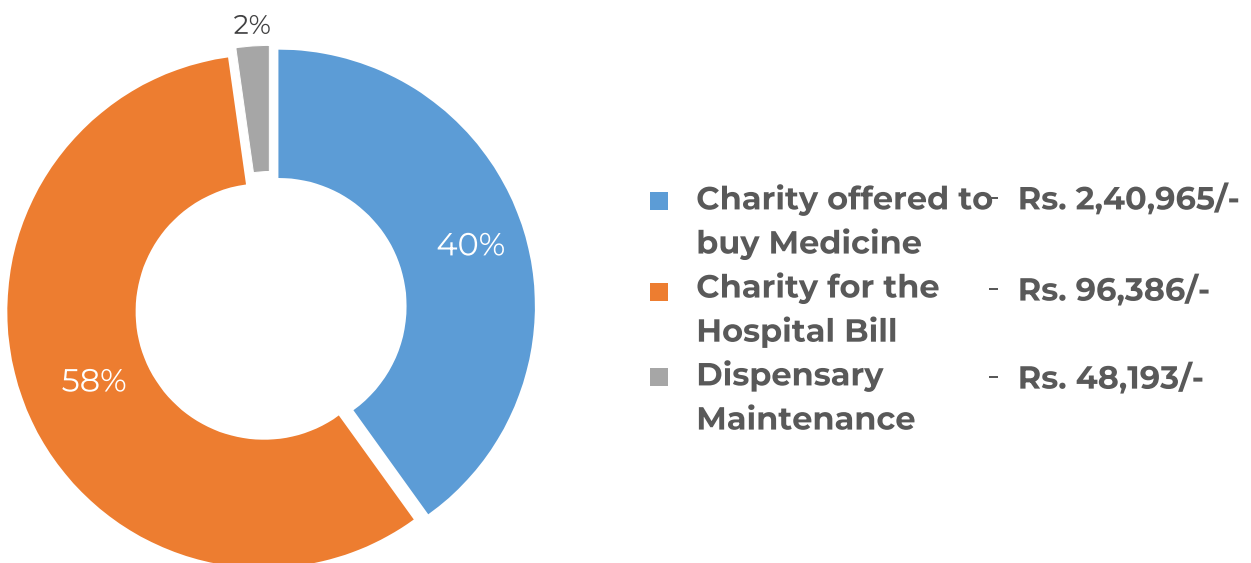
### Educational assistance for year 2021-2022

### Medical assistance for the FY year 2021-2022

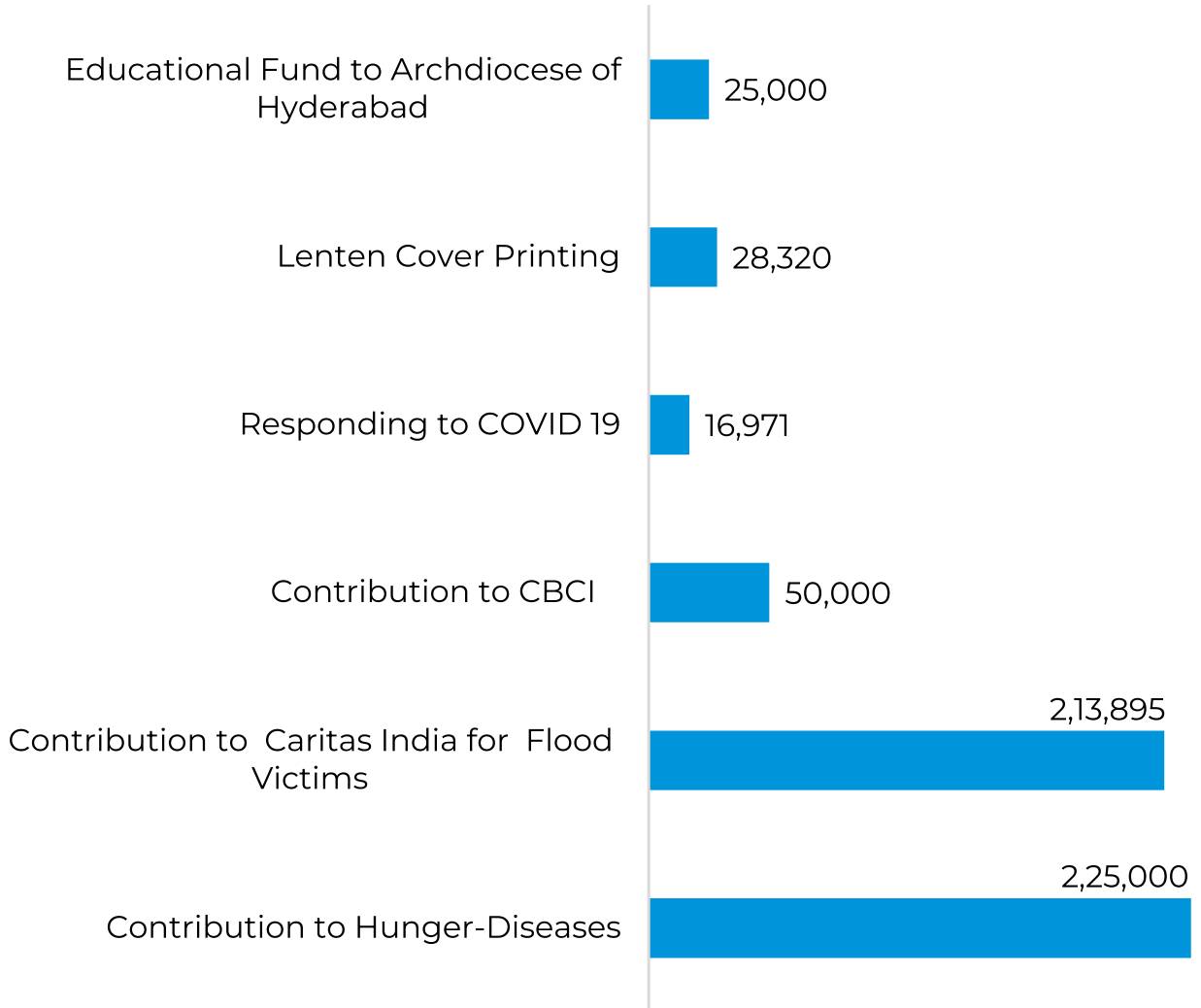

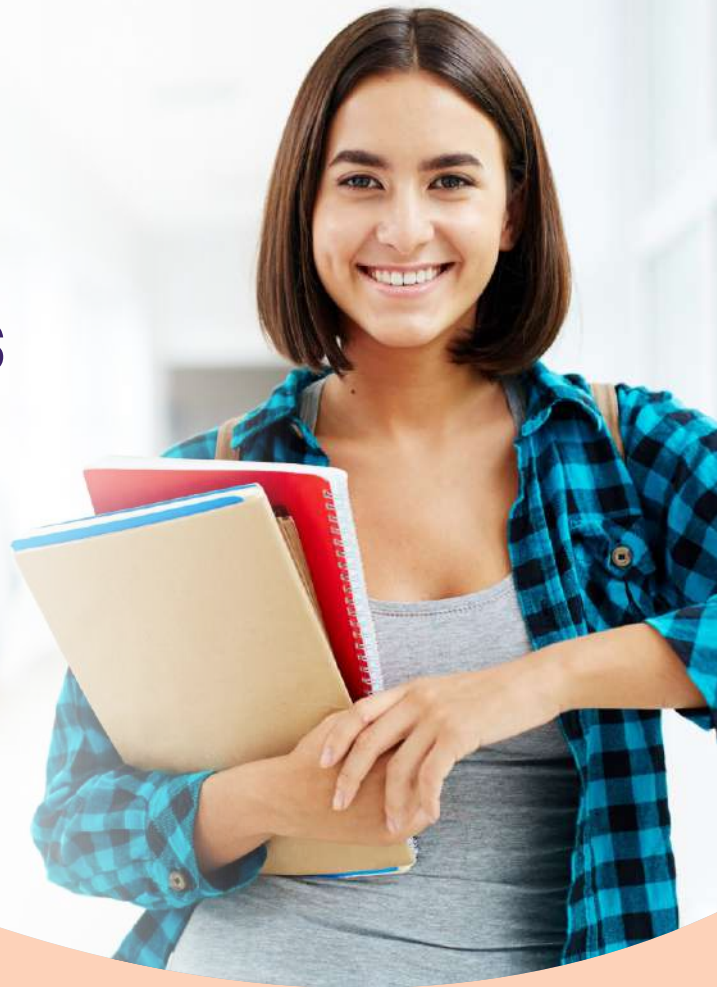
